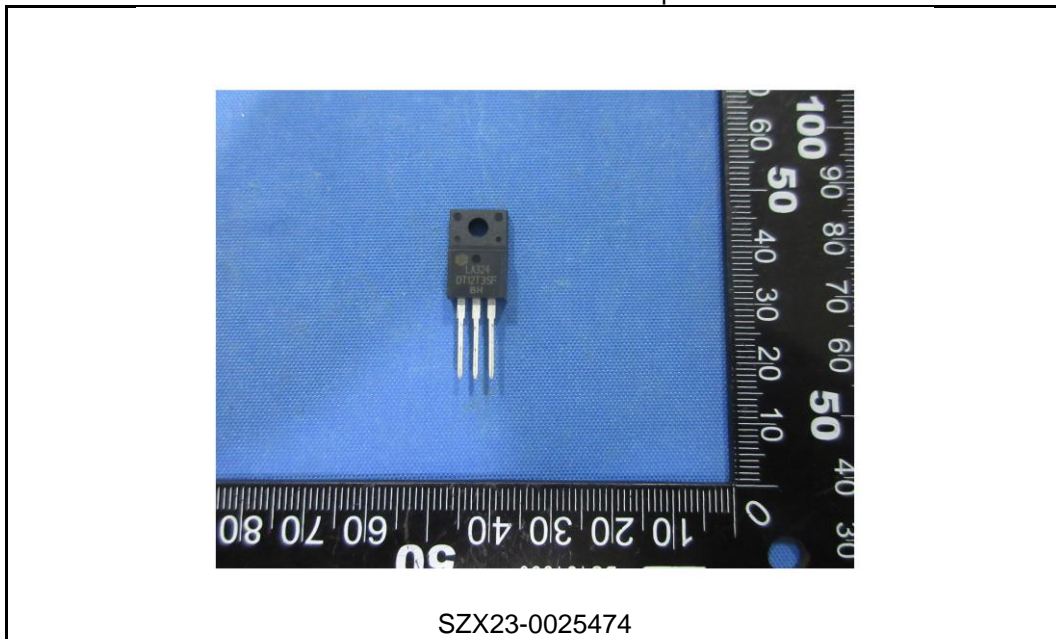

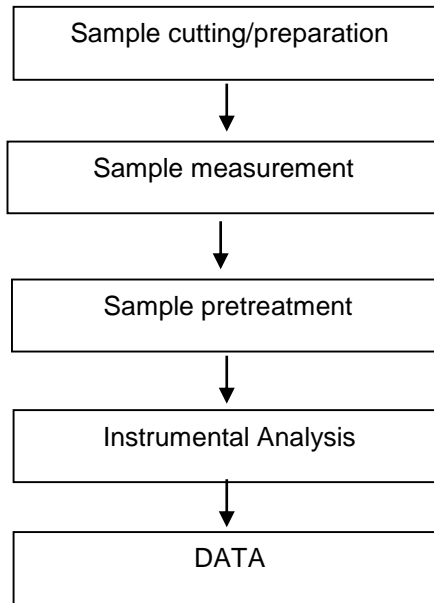

Testing Flow Chart



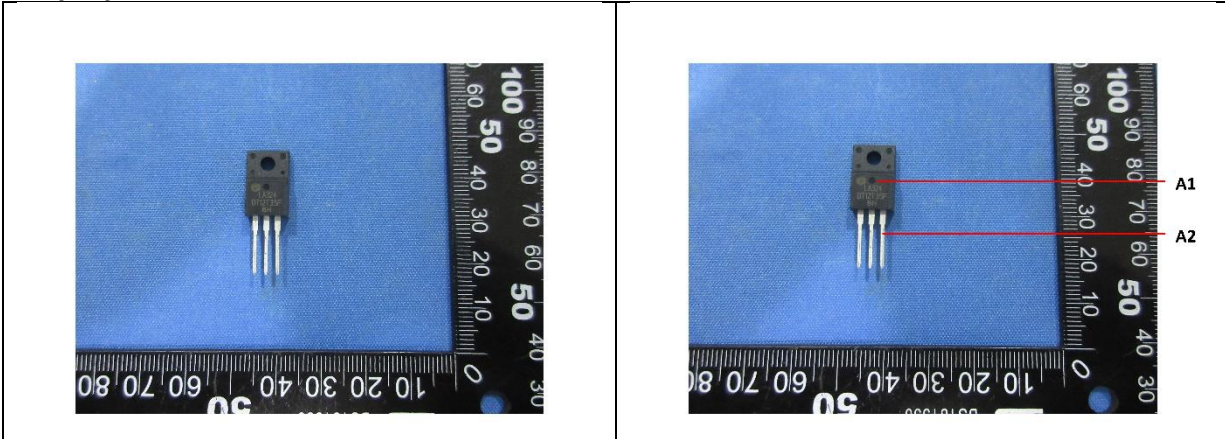
